# What is a Fire Territory?



- 
- Two or more taxing units (townships, municipalities, fire districts) that share physical boundaries can join to form a new Fire Territory, or may join an existing Fire Territory
  - There are three fire districts in Floyd County:
    - Georgetown Township Fire Protection District (GTFPD)
    - Highlander Fire Protection District (HFPD)
    - New Albany Township Fire Protection District (NATFPD)
  - GTFPD and NATFPD are already participants in a Fire Territory



# Floyd County Fire Territory Background



- 
- In May 2024, NATFPD approached GTFPD about forming a Fire Territory
  - The Floyd County Fire Territory started operations January 1, 2026
  - Highlander Fire District expressed interest in joining the Floyd County Fire Territory as part of large-scale update to Fire/EMS for Floyd County

# Why Join a Fire Territory?

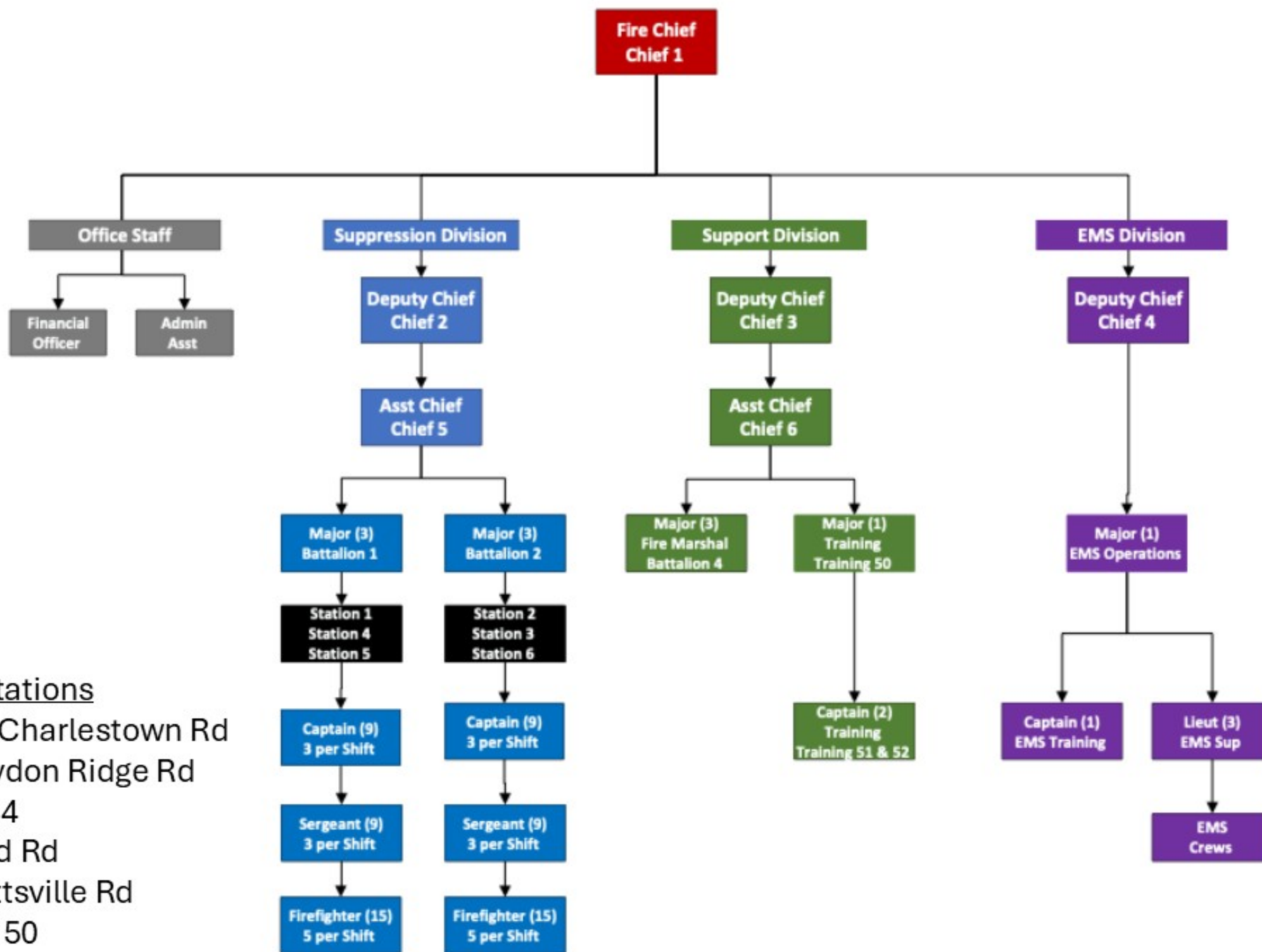


- 
- Better align fire protection with community needs
  - Provide consistent professional fire protection for Floyd County
  - Take advantage of operational efficiencies:
    - Equipment
    - Training
    - Human Resources
    - Accounting
  - Work towards implementing "Closest Station Dispatch"

# Floyd County Fire Territory



- 
- Each Fire District is a Participating Unit
    - Expansion would include HFPD as a Participating Unit
  - GTFPD is the Provider Unit and will continue in that role
    - Chief Ned Wiseman is the Chief of the Fire Territory
    - Chief Tim Franklin is Deputy Chief of Suppression Division
    - Chief Jake Barnes will be Deputy Chief of Support Division
    - All current firefighters will be employed by a single Department under the Fire Territory
    - The existing 2023 Collective Bargaining Agreement between GTFPD and International Association of Fire Fighters, AAFL-CIO, CLC and Georgetown Professional Fire Fighters Local 5393 as amended will remain as the CBA for the Fire Territory

# Process to Expand Fire Territory

- 
- Between January 1<sup>st</sup> and March 31, 2026, each District must:
  - Hold 3 public hearings to educate community:
    - Pineview Government Center at 5:30pm
    - January 28<sup>th</sup>
    - February 11<sup>th</sup>
    - February 25<sup>th</sup>
  - Hold 4<sup>th</sup> Adoption meeting to vote on resolutions to expand the Territory
    - Pineview Government Center at 5:30pm, March 11<sup>th</sup>
  - If approved, HFPD will join the Fire Territory on January 1, 2027
